Irrespective of the requirements of this Guidance Document, MDA has the right to request for information or material, or define conditions not specifically described in this document that is deemed necessary for the purpose of regulatory control.

MDA has put much effort to ensure the accuracy and completeness of this guidance document. In the event of any contradiction between the contents of this document and any written law, the latter should take precedence.

MDA reserves the right to amend any part of the guidance document from time to time.

1 Introduction

ASEAN Medical Device Directive (AMDD) is the Agreement established for the purpose of harmonising medical device regulations in ASEAN countries. This Agreement is entered into force on 1 January 2015. Malaysia has signed this Agreement on 23 April 2020.

The definition of medical device has been stipulated in Article 2 of AMDD. In Malaysia definition of medical device is specified in Section 2 of Medical Device Act 2012 (Act 737) and it determines the scope of regulatory control.

It is the responsibility of the manufacturer to classify a medical device based on the level of risk it poses, its intended use and the vulnerability of the human body in accordance with the prescribed manner.

This guidance document will be updated on a yearly basis to reflect the latest decisions of the ASEAN Medical Device Committee (AMDC).

2 Scope

This guidance document provides the list of borderline products whether they are medical devices or non-medical devices based on their intended purpose as claimed by the manufacturer which is harmonised in ASEAN.

3 Terms and definitions

For the purposes of this document, the terms and definitions in Act 737, the regulations under it and the following terms and definitions apply.

3.1 borderline products

Products that are difficult to distinguish from a medical device, for example products that might be medicines, cosmetics, food supplements, biocidal products or personal protective equipment. These products are called borderline products until their status of medical device or non-medical device has been decided.

3.2 ASEAN

Association of Southeast Asian Nations, or ASEAN, is a political and economic union of 10 members states in Southeast Asia, which are Brunei, Cambodia, Indonesia, Laos, Malaysia, Myanmar, Philippines, Singapore, Thailand and Vietnam.

3.3 intended use/ purpose

The objective intent of the manufacturer regarding the use of a product, process or service as reflected in the specifications, instructions and information provided by the manufacturer.

3.4 manufacturer

As defined in Section 2 of Act 737.

3.5 medical device

(a) any instrument, apparatus, implement, machine, appliance, implant, in-vitro reagent or calibrator, software, material or other similar or related article intended by the manufacturer to be used, alone or in combination, for human beings for the purpose of:

- (i) diagnosis, prevention, monitoring, treatment or alleviation of disease;
- (ii) diagnosis, monitoring, treatment, alleviation of or compensation for an injury;
- (iii) investigation, replacement or modification, or support of the anatomy or of a physiological process;
- (iv) support or sustaining life;
- (v) control of conception;
- (vi) disinfection of medical device; or
- (vii) providing information for medical or diagnostic purpose by means of in-vitro examination of specimens derived from the human body, which does not achieve its primary intended action in or on the human body by pharmacological, immunological or metabolic means, but that may be assisted in its intended function by such means; and

(b) any instrument, apparatus, implement, machine, appliance, implant, in-vitro reagent or calibrator, software, material or other similar or related article, to be used on the human body, which the Minister may, after taking into consideration issues of public safety, public health or public risk, declare to be a medical device by order published in the *Gazette*.

4 Harmonised Borderline Products in ASEAN

4.1 General requirements

Harmonised borderline products listed are in accordance with the definition of medical device and agreed upon by the ASEAN Medical Device Committee (AMDC). The list of harmonised borderline products has been published in the www.asean.org.

The list of borderline products that are classified as medical device or non-medical device are as listed in Annex A.
